## ELECTRICITY SUPPLIES TO TRADE STANDS AND CATERING SITES

### APPROXIMATE GUIDE FOR LOAD REQUIREMENTS

1. Applications for an electricity supply should be completed and returned at once. Owing to the limited timescale, any applications received and paid for in full at the appropriate rates after 22<sup>nd</sup> May 2026 will be subject to a 50% surcharge and will be dealt with on a 'first come first served' basis with no guarantee of supply being made.
2. **Power requirements will be available from 6.00am on the first day of the Show, unless otherwise requested (See item C).**
3. Eastern Power Systems is unable to guarantee the connection of supplies unless application forms are confirmation stamped and full payment has been received.
4. In the absence of instructions to the contrary on the application form, the cable will terminate on the Stand at a position to be decided by Eastern Power Systems. The connection charge **does not** include internal wiring.
5. Exhibitors requiring internal wiring should order their requirements through Eastern Power Systems on the application form with a sketch showing all points. All installations must be to IEE 18<sup>th</sup> Edition Regulations standards. It is essential that the work is completed by **19<sup>th</sup> June 2026** otherwise Eastern Power Systems cannot guarantee that the installation can be connected to the mains network supply prior to the opening of the show. In all cases Eastern Power Systems will connect the supply.
6. Eastern Power Systems will test all installations before connection and a separate charge will be made for any necessary re-test. Once the installation has been inspected, additions are only permitted by written consent of Eastern Power Systems and a further inspection will be made.
7. Any requests for services or complaints, prior to or during the Show should be made to the **Eastern Power Systems Showground Office (Tel: 01603 213717)**. Complaints about supply or internal wiring cannot be considered after the Show.
8. The Exhibitor will be responsible for checking that their requirements have been catered for. Any additional works carried out at the Exhibitor's request or at the discretion of Eastern Power Systems should they consider the original order inadequate for the Stand's power requirements, will be recorded by the Engineer and the Exhibitor will be charged by Eastern Power Systems.
9. Exhibitor will be held responsible for the safe keeping of internal installations and fittings on their Stands. Damages should be reported immediately to Eastern Power Systems. Damage and losses will be chargeable to the exhibitor after the Show.
10. The Exhibitor must notify Eastern Power Systems on the first Show Day at what time their Stand will require disconnection after the Show. This is essential so that live cables are not left on the Showground when the Stand has been dismantled.
11. Where the exhibitor requires a supply/connection to be completed specifically prior to the Show dates, they must arrange this with Eastern Power Systems before 22<sup>nd</sup> May 2026. The Exhibitor will be required to meet any extra costs to Eastern Power Systems arising from such an early supply/connection request. It will be necessary to interrupt such early supply/connections in order to supply/connect other Stands safety as and when required.
12. The power may have to be cut off in the event of an emergency and there may not be time to issue a warning. If you are aware that this has happened, you should switch off any appliances that are operated by electricity until the supply has been restored. Eastern Power Systems cannot be held responsible for any loss or damage arising from a loss of supply or reduction in voltage.
13. The Exhibitor is required not to connect any faulty equipment or appliances to the Stand's electricity supply. Any such faulty equipment or appliances connected will result in the disconnection of the supply. The offending item must be disconnected and repaired before being reconnected to the Stand supply.
14. Where an Exhibitor notifies Eastern Power Systems in writing, at the time of making application for such a supply, that computers and/or other equipment susceptible to variation in voltage to form part of a display Eastern Power Systems will endeavour to arrange an individual supply to the stand subject to the Exhibitor bearing any cost involved.
15. The Exhibitor is required at all times to have an appropriate fire extinguisher prominently sited close by electrical equipment and maintained in a serviceable condition. In no circumstances should water extinguishers be used on electrical fires or near electrical equipment.
